

## How to determine your legislative asks

### House of Representatives

**First step:** [Check](#) to determine if your Representative has cosponsored any of the bills below.

**Second step:** If not, ask them to cosponsor the first three bills. If they have, after thanking them for the bill(s) they have already signed onto, ask for them to cosponsor the others on the list. Note: the bills are listed in order of priority.

If your Representative is a Democrat:

2. [Improving Seniors' Timely Access to Care Act](#) (H.R.3173)
3. [Expanded Telehealth Access Act](#) (H.R.2168)
4. Maintain stability for providers paid under the Medicare Physician Fee Schedule by retaining 2021's 3.75% increase to the conversion factor through at least 2022 and 2023
5. [Eliminating Provider Relief Fund Tax Penalties Act](#) (H.R.2079)

If your Representative is a Republican:

### Senate

Note: In the Senate, the first three bills have yet to be introduced but it is possible that they will be introduced before the August recess begins.

**First step:** [Check](#) to determine if your Senator has cosponsored any of the bills below.

**Second step:** If not, ask them to cosponsor the listed bills. If they have, then thank them for their support of the bill(s) they have signed onto and ask for them to cosponsor the others on the list.

If the Senator is a Democrat, ask for them to cosponsor this upcoming legislation:
